

Terms of Service

The Oklahoma Real Estate Commission mandates 24 areas of study for the Pre-License Course.

Once you enroll in a course, you have up to 6 (six) months to complete. If you don't complete the course in 6 (six) months, you will have to retake the course.

Once you have paid for the course, you will gain access to the online course material in the member's only area of this website. You will create a user name and password to log in and out of online training course.

To successfully complete this course, you must read each chapter and each chapter has a test that you must pass with a score of 80% or higher. You can only proceed to the next chapter after each successful completion of a chapter.

There are 11 (eleven) chapters of "Additional Study Material" throughout the course. At the end of these chapters are test questions and word matching to pass with a score of 80% or higher before proceeding.

After reading and passing all chapters, you will take 3 (three) practice tests, passing each with a score of 80% or higher to proceed.

Throughout the course, once you have completed a chapter, you can return to any chapter or test to study.

Upon successful completion of all of the chapter tests and practice exams, email Charlotte for a link to the course final exam. You will receive the link within 24 hours of request. Then you will be prepared to take the end of course school exam. It is 200 questions with a passing score of 80%. If you don't pass it the first time, you will have an option to take it a 2nd time. Should you fail the second exam, you will need re-enroll in the course.

At some point while taking this course, you will want to complete the Application for Real Estate License. The application is on the website. This application must be submitted to the Oklahoma Real Estate Commission prior to taking the state exam. Instructions for completion are on the application.

Upon successful completion of the Pre-License Course, you will receive a Certificate of Completion via email. You will submit the certificate to the Oklahoma Real Estate Commission. Once the Oklahoma Real Estate Commission has received your application and Certificate of Completion, they will email you a link to schedule a time to take the state exam.

When you clink on the link, you'll be directed to the website for PSI. You'll be taking the Oklahoma Salesperson Exam. After enrolling you will see the available schedule for testing.

The cost for the test is \$60.00. The test is 130 questions and you are given 3 hours to take the test.

As you study, you will have an option to email the instructor with questions or clarifications. She will respond within 24 hours.

Once you enroll, the enrollment fee is **non-refundable**. You may call the instructor, Charlotte Greganti, at 405-209-8597, if you have any questions or concerns.
